

THE JBL TRUE SUMMER PROMOTION
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES, THE DISTRICT OF COLUMBIA, AND CANADA (EXCLUDING QUEBEC) WHO ARE AT LEAST EIGHTEEN (18) YEARS OLD OR THE AGE OF MAJORITY IN THEIR PLACE, PROVINCE OR TERRITORY OF RESIDENCE AT THE TIME OF ENTRY.

- 1. PROMOTION PERIOD:** The Promotion begins on June 21, 2021 at 12:00 PM Eastern Time ("ET") and ends on August 14, 2021 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion official clock.

- 2. ELIGIBILITY:** The Promotion is offered only to legal residents of the fifty (50) United States, the District of Columbia, and Canada (excluding Quebec) who are at least eighteen (18) years of age or the age of majority in their place, province or territory of residence at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Promotion Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. If it is the entrant's first visit to the Website, then he/she must complete and submit the registration form by providing the information requested by Sponsor including, but not limited to: complete first and last name, street address (P.O. Boxes are not permitted), city, state/province/territory, ZIP/Postal Code, daytime phone number, date of birth, and agree to these Official Rules. Upon subsequent visits, entrant will only need to enter his/her email address. Entrant may then select his/her prize preference (prize cannot be guaranteed). After submitting the required information, entrant will automatically receive one (1) entry into prize drawing. After registering, an entrant may follow the links and instructions to complete the below activities to receive entries:

Limit: Entrant may only follow Sponsor on Instagram one (1) time during the Promotion Period. If an entrant does not have an Instagram account, he/she can create one at no cost from the Instagram app. Please note that an entrant must agree to comply with the Instagram Terms of Use (<https://www.instagram.com/about/legal/terms/>) and Privacy Policy (<https://www.instagram.com/about/legal/privacy/>) in order to participate in this Promotion. Entrant specifically agrees to release Instagram from any and all liability associated with this Promotion. This Promotion is in no way sponsored, endorsed or administered by, or associated with Instagram or any of their affiliates.
- B. Visit the Sponsor's Website:** During the Promotion Period an entrant may follow the links and instructions to visit the Sponsor's Website. Entrant will receive one (1) entry into the Promotion for clicking the link and visiting the Sponsor's website. Limit: Entrant may only receive one (1) entry for visiting the Sponsor's Website during the Promotion Period.
- C. Make A Purchase:** During the Promotion Period, an eligible entrant may purchase any one (1) participating JBL product (see Appendix for list of participating products) online and/or at any participating store, ("Qualifying Purchase"), while supplies last. Entrant may then visit the Website and follow the on-screen prompts and upload a photograph of the original receipt showing the Qualifying Purchase. It is recommended that purchaser first print his/her name on the original register receipt; sign and date the receipt; and circle the qualifying product on the receipt before uploading the receipt. The file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 10 MB. Receipts must be submitted by 11:59:59 PM ET on August 14, 2021 to be valid. It is strongly recommended that the entrant maintain possession of the original or photocopy. The entrant should not give a receipt to any store employee. Upon approval of receipt, an entrant will receive ten (10) additional entries into the Promotion. There is a limit of one (1) unique receipt upload per person during the Promotion Period. An entrant may not submit the same receipt more than one (1) time. Duplicated receipts will not be accepted. Receipts must be readable. Mechanical reproductions, altered receipts or unreadable receipts will not be accepted. Receipts submitted in excess of the limits set forth herein will not be accepted.

Mail-In Without Making a Purchase: To earn an entry without making a purchase, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. A Mail-In Entry is worth ten (10) entries. An entrant may mail-in one (1) per day during the Promotion Period. Following this method of entry, an entrant will receive ten (10) entries into the Promotion.

All Mail-In Entries must be postmarked by August 14, 2021 and received by August 24, 2021. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Limit: Regardless of method of entry, an entrant will receive no more than ten (10) entries during the Promotion Period for either mailing-in or uploading a receipt. If more than the stated number of entries are received from the same person, telephone number and/or e-mail address, the

entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. RANDOM DRAWING: On or about August 25, 2021, Administrator will select three (3) potential grand prize winners and seventy-five (75) potential first prize winners from among all eligible entries received during the Promotion Period. Each winner is deemed to be a potential winner, pending verification of the entrant's eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, at their sole and absolute discretion. Canadian residents will be required to correctly answer a timed mathematical skill-testing question as further described in Section 6 before being declared a potential winner.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

Only one (1) Poolside Party Bundle is available in the Promotion.
- iii. On Your Grind Bundle (1):** Includes a Peloton Bike, a Hydroflask water bottle, \$100 Peloton gift card, a Recovery snack kit, a UA workout bag, a pair of JBL Sports Headphones, a JBL Boombox2 ("On Your Grind Bundle"). The ARV of the On Your Grind Bundle is \$2,885.90 USD / \$3,494.52CAD. Only one (1) On Your Grind Bundle is available in the Promotion.

No more than three (3) Grand Prizes will be awarded in the Promotion, one (1) of each bundle. Prizes are available on first come first served. Each potential winner may select his/her Grand Prize based on availability and order of winner selection.

B. First Prizes (75): Each first prize is a pair of JBL Endurance Peak 2 Headphones (“First Prize”). The ARV of each First Prize is \$99.95 USD / \$121.03 CAD. No more than seventy-five (75) First Prizes will be awarded in the Promotion.

C. Total ARV: The total ARV of all prizes available in this Promotion is \$15,525.80 USD / \$18,811.37 CAD*

* All currency conversions based on listed exchange rate as of June 8, 2021.

D. Odds of Winning: The odds of winning a prize depend on the number of eligible entries received during the Promotion Period.

E. General: There is a limit of one (1) prize per person. Details of prizes will be determined by Sponsor in its sole discretion. In no event will more than three (3) Grand Prizes and seventy-five (75) First Prizes, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

Promotion Entities shall not be held responsible for any delays in awarding a prize for any reason.

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
